This application must be completed for issuance or renewal of an Orange County Sanitation District (OC San) **Waste hauler Permit For Discharge Of Non-Hazardous And Non-Industrial Wastewater**. For OC San to properly evaluate, process, and issue a Permit, the applicant must answer all questions and provide relevant information for a complete permit application and must comply with all the following:

1. **All Waste haulers must have a current LWH registration with the Orange County Health Care Agency (OCHCA).**
 To obtain a Liquid Waste Hauler (LWH) registration, please make an appointment with OCHCA at (714) 433-6284 before returning this application. Attach a copy of the Applicant's valid Orange County Health Care Agency registration to this application once obtained.
2. **Incomplete applications will NOT be processed.** Please write "N/A" if the information requested in any section of the application does not apply to the applicant.
3. **New Applicants must include copies of the following information (whichever is applicable):** Articles of Incorporation; most recent business entity report from the California Secretary of State; and/or current Business License. OC San requires a new copy of a current Business License each year.
4. **The permit application must be signed by the Responsible Officer as defined in 40 CFR 403.12 (l)(1)(i),** also defined on Page 6. OC San will not process the permit application if it is not signed by an individual meeting the definition of Responsible Officer. One Responsible Officer and one Designated Signatory may be defined per application.

Instructions:

This application must be completed for issuance of Orange County Sanitation District (OC San) vehicle registration and inspection. For OC San to properly evaluate, process, and issue new vehicle decals, the applicant must answer all questions and provide relevant information for a complete permit application and must comply with all the following:

1. **Incomplete applications will NOT be processed.** Applicant must write “N/A” if the information requested in any section of the application does not apply to the applicant.
2. **Copies of the vehicle registration must be submitted with the application.** If the vehicle being permitted is a trailer, also include the registration for the vehicle which will be used to tow the trailer.
3. **All new vehicles must have an active Orange County Health Care Agency (OCHCA) Liquid Waste Hauler (LWH) registration prior to applying for OC San registration.** The vehicle/trailer being permitted must be present on the OCHCA website active list.
4. **Once approved, the new vehicle will undergo an OC San inspection.** The vehicles **must** have the following during the inspection:
 - 15' MAX length discharge hose with 4-inch Chem-Lock coupling.
 - Active OCHCA permit decal on the tank.
5. **The permit application must be signed by the Responsible Officer as defined in 40 CFR 403.12 (I)(1)(i).** OC San will not process the permit application if it is not signed by an individual meeting the definition of Responsible officer or Designated Signatory. One Responsible Officer and one Designated Signatory may be defined per permit.
6. **Once Completed, deliver the original “Wet Signature” application** with a photocopy of the check or payment receipt by mail or in-person to *OC San Resource Protection Division, 18480 Bandilier Cir Fountain Valley, CA 92708*. Electronic (email) submissions will **NOT** be accepted.
