- I. The Orange County Sanitation District (OC San) collects sanitary sewer service charges on the property tax roll in accordance with OC San Ordinances. Parcel owners have the right to communicate directly with the OC San staff regarding service charges placed on their parcels or they may authorize an agent to represent them.
- II. The owner(s) have elected to authorize the agent named below to act on our behalf as Agent in matters relating to the OC San service charge placed on the property tax bill for those parcels owned by the undersigned as listed above. The Agent has full permission to act on the Owner's behalf in connection with all matters pertaining to the service charge for any listed parcels, and OC San is authorized to release any information relating to the listed parcels' service charge to the designated Agent.

- III. Having delegated the above authority, the owner accepts full responsibility for any action taken within the scope of Agent's authority as set forth above. The owner understands that OC San will review the service charges on said parcels and make corrections accordingly. Corrections made by OC San may decrease or increase service charges.
- IV. This Authorization expires automatically one year from date of execution below. The Authorization may be revoked prior to the indicated term by a certified letter signed by the parcel owner, a partner, a corporate officer or other authorized person. Such revocation shall become effective when received by OC San.
- V. By executing this form, we are also authorizing OC San to access our water consumption information from the water service provider.
- VI. I declare under penalty of perjury under the laws of the State of California that the information provided on this application is true and correct in all respects and that I am the Owner or am authorized to sign this letter of authorization of behalf of the Owner.
